RENTAL AGREEMENT: It is the SOLE responsibility of the person or organization entering into this Agreement (hereinafter referred to as the "hirer") to ensure that every precaution is taken to avoid injury to people or damage to the inflatable unit.

It is the responsibility of the hirer to inspect all of the rental equipment before you sign the RENTAL AGREEMENT to ensure that all equipment is in good working conditions. Jump Start Rentals Ltd. reserves the right to refuse setting up the inflatable unit if the location is deemed to be unsafe or weather conditions that go against the manufactures operation regulations.

The hirer is responsible and liable for any damage or injuries occurring from or as a result of misuse or reckless use on or near the inflatable. There are inherent risks in the participation in or on any inflatable interactive device. Participants and supervisors should be aware that they have a duty to exercise good judgment and act in a responsible manner while in or on the inflatable. An adult must supervise all individuals using the inflatable unit at all times and must also supervise the set up and take down of the inflatable. You must follow specific weight regulations which are given in the description of each inflatable unit. Failure to do so will cause damage to persons or the inflatable unit. Persons using the inflatable unit do so at their own risk. These guidelines are for the safety of all persons using the inflatable unit, and it is the sole responsibility of the hirer to ensure they are adhered to. Jump Start Rentals Ltd. will not accept responsibility for any damage or injury to anyone using the inflatable unit however caused.

Do not leave the inflatable unit or any accessories outdoors when not in use, NEVER leave equipment outside overnight, or when it is raining. Leaving equipment outside, overnight or during rain will result in a \$50.00 damage penalty from the renters security deposit.

The inflatable unit MUST NEVER be dragged over or set upon rough surfaces (example: Asphalt, concrete, gravel, or any other rough surface). You MUST check the area where the inflatable unit is to be set up beforehand, anything that could puncture or damage the inflatable unit MUST be removed from the area.

Damages due to negligence on the part of the hirer or their guests will NOT be covered by our RENTAL INSURANCE. The RENTAL INSURANCE will be deemed VOID if the rules and regulations stated in our RENTAL AGREEMENT are not followed, and damage to the rental unit occurs.

***For your information, safety and enjoyment we recommend the following ***

RULES & REGULATIONS

- 1. The inflatable unit has an age limit of 14 years. (Unless otherwise stated in the inflatable unit description). Please ensure that no one over this age uses any part of the inflatable unit, especially adults. All riders must be over 3 years old and/or 36' in height. Due to safety, manufacturing and insurance liabilities, It is imperative that the renters do not exceed the recommended child capacity.
- 2. A responsible and qualified adult, over the age of 21, must supervise children at all times while they are on the inflatable unit. Entrance must be kept clear of onlookers so operator has a clear view.
- 3. Please do not allow anyone on the inflatable unit while inflating/deflating as this is dangerous.
- 4. Children are not allowed to climb, sit or hang on the inflatable unit walls. This is dangerous and must not be allowed at any time. NO user is ever to slide head first down the slide of the inflatable unit. Always make sure slide is clear of others before sliding and never stand up on slide platform.
- 5. Do not allow children to bounce on the front safety step as a child could easily bounce off the inflatable and get hurt. The safety step is to assist users in getting on/off safely. Make sure the children are bouncing away from each other and away from the sides.
- 6. Ensure the inflatable unit is not overcrowded. (maximum amount of users stated in the description of the inflatable unit) Limit the number of users (size and age) to allow enough room for each child to play safely. Try to avoid small and large children using the inflatable unit at the same time.
- 7. All shoes, badges, jewelery must be removed. We also recommend spectacles be removed before using the inflatable unit to avoid injury to people using the equipment and harm to the inflatable unit
- 8. No food or drinks or chewing gum to be consumed while on the inflatable unit to avoid both damage to the unit and the possibility of choking.
- 9. No face paints, party poppers, colored streamers or silly string as these can cause damage to the unit and can also stain the inflatable unit for which you will be liable for payment to clean or repair. (Please note these products will cause damage to the inflatable unit that cannot be repaired).
- 10. No smoking, fires, barbecues or any open heat to be used on or around the inflatable at any time. Material will burn or melt.
- 11. ABSOLUTELY NO PETS, TOYS OR SHARP OBJECTS to be allowed on or around the inflatable unit at any time.
- 12. It is advisable to ensure that no one with any history of back, neck problems or any other disability use the inflatable unit. Absolutely no pregnant women and any other persons susceptible to injury from falls, bumps and bouncing are not permitted in or on the inflatable unit at any time.
- 13. Children are not allowed to push, collide, fight or behave in a manner likely to injure or cause distress to others. Children must not attempt somersaults or any other acrobatics, and must be clothed appropriately with nothing being able to fall out of their pockets. Operator must incorporate use of whistles or other devices to signal misbehavior.

- 14. In the event of rain the inflatable unit must be deflated. Using the inflatable unit in the rain is unsafe and NOT permitted. The blower MUST be stored in a dry place during rainstorms. Failure to unplug the blower during a rainstorm could possibly result in electric shock by participants. Security Fee is NON REFUNDABLE if equipment is not being properly stored. The inflatable unit will become VERY slippery during rainstorms and is NOT safe for jumping or playing on. Failure to follow these rules could result in serious injury. When safe to re-use switch back on and towel dry any remaining wetness before allowing children back on. (Please note bubbling is normal).
- 15. Occasionally check that the inflatable unit is still securely pegged down. The inflatable unit must be anchored to the ground at all times with steaks or sandbags and should never be removed.
- 16. Never switch the blower on and off while the inflatable unit is in use. If the inflatable unit is not being used for any part of the day please switch the blower off at the mains.
- 17. Keep children away from the blower at all times. Do not insert fingers, toes or any foreign objects into the blower, this may cause injury. The blower must be operated by adults only.
- 18. Unload and deflate structure in case of high winds over 25 mph.
- 19. Do not use in direct sun in temperatures above 90 degrees Fahrenheit. Direct sun can heat surfaces to unsafe temperatures for play.
- 20. If the inflatable unit fails for whatever reason, tighten blower vent and evacuate immediately and calmly to prevent injury. The blower has a safety reset button, try pressing this, also check the fuses and make sure the blower tube or deflation tube has not come undone or something has not blown onto and is obstructing the blower. In the event that it overheats, or loses power, switch the blower off at the mains, then switch it back on again 2 minutes later and it should restart. If it does not, inform us immediately with a phone call.
- 21. Please remember if the inflatable unit is dirty or damaged when collected the hirer is liable for the full repair or cleaning costs.
- 22. Do not set or operate near any known hazards. This includes overhead hazards such as power lines and ground hazards such as sprinklers, etc.
- 23. Age Limits: 3 years to 14 years old NO ADULTS unless indicated on the inflatable.
- 24. If spills do occur the inflatable must be cleaned with a damp cloth no CHEMICALS.
- 25. An additional 3-5 feet of unobstructed perimeter around each side of the inflatable house, this is the bare minimum.
- 26. Drop off time is 9-12pm and pick up time is in between 7-9pm. Additional hours \$25.00/hr. Please Note: Depending on our deliveries that day we may need to drop off earlier or picked up later. We guarantee 12pm-7pm.
- 27. If the weather is looking rainy or windy on the day of your event, either we will be in touch with you or you can call us for our opinion. IF WE DEEM THE WEATHER TO BE INADEQUATE TO SAFELY OPERATE OUR EQUIPMENT WE RESERVE THE RIGHT TO REFUSE RENTING THE INFLATABLE. In the event of rain the inflatable must be deflated, using the inflatable during a rainstorm is unsafe, may cause injury. The blower must be stored in a dry place. Failure to do so may result in electric shock or serious injuries. If we are on route and you decide to cancel your deposit of \$50.00 will not be returned.
